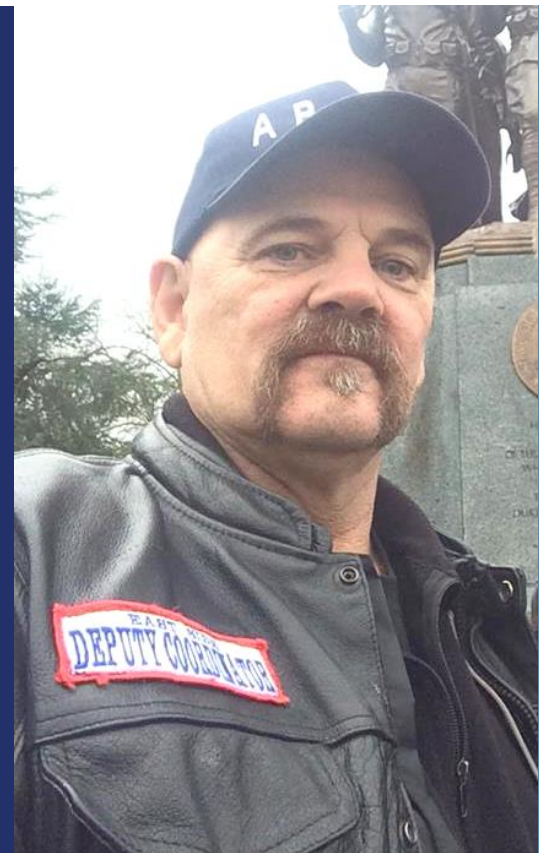

## ROAD SIGNS ARE HERE

We have received 2 ft. x 2 ft. road signs. I have been trying to get them to you as quickly as possible. Delivered some to Jenny (Products), so the folks who live in the Tacoma area contact her to make arrangements to get them. This is the beginning of our motorcycle awareness program. If this works out we can purchase another 100 signs next year with a new message. This is also a membership drive as we are putting our name all over the state.

If you have the signs you will have to be creative with how and where you put them. I suggest the first thing we do with them is put your chapter name and contact info on the back of them. If someone has a problem let them call. Explain we are trying to save motorcycle rider lives with awareness. ABATE of Washington is doing their part to reach target zero deaths. Last year 100 brothers and sisters were killed on Washington state highways. That has got to change. We do not need legislation to make this happen we just need to be proactive.

You can approach the city officials and request they allow us to put them up using existing sign post for things like no parking signs or welcome to --- etc. or approach business owners who have buildings close to the roadway. Land owners who have fences or other buildings close to the road also work. DOT will take the signs if they are on DOT posts. If for some reason you can't find a place for them please return to products. If other Chapters can use them we will pass them on. If we have to, we will sell them for approximate \$60 each. Just don't let them set in the storage shed or garage.

If anyone has a good suggestion on how to get them up in public, pass it on to the rest of us.

## LEGISLATIVE REPORT

The July BOD has come and gone and unfortunately, circumstances related to my car crash and injured knee caused me to miss the July BOD so the Legislative discussion and voting for this session's Bills was tabled (family issues caused Brian to miss the BOD also). I would like to thank Doug Bowers for filling in and relaying the LAO report for everyone at the BOD.

This year has definitely had a lot of challenges when it comes to ABATE members getting together to discuss our issues and plan our efforts for the year. Brian, Scott Robinson and I have "met" several times via phone to come up with a strategy to present ABATE's legislative issues to the membership. This year, a review of the possible Bills that we will run with this biennium is going to be sent to all Chapter Coordinators so that they can include the review in their meeting agendas. Hopefully, the chapter members will have a chance to discuss the Bills and vote on which ones they would like to see us present to the legislators. Following the chapter members' vote, the results should be sent via email to [legislative1@abate-wa.org](mailto:legislative1@abate-wa.org).

It is our decision to run no more than 3 Bills during any one legislative session and the bills that we currently have developed include:

- Helmet Pilot Bill: we should never let up with this effort, advice from Legislators who are pro-ABATE
- Lane Sharing Bill: we should always pursue this effort for our safety
- Right Lane Shoulder Riding: Allows Motorcycles to travel along the right hand shoulder if traffic is 25 mph or slower. This bill has been discussed with Legislators already and seems to have support among several of them.
- Weight Fee - allows for a weight class payment scale for vehicles that weigh less than 4,000 lbs.
- New one suggested - Handicap parking space allowance - this bill would allow more than one bike per handicap spot if at least one bike has a decal

It is recommended by the LAOs that the Helmet Bill, the Lane Sharing Bill, and the Right Shoulder Lane Bill be pursued during this biennium.

It is understood that these changes put a little more effort onto the Coordinators' shoulders and we certainly appreciate any effort that can be put forth by all members to make this a successful legislative year.

A detailed list of the aforementioned Bills will be forwarded to the Chapter Coordinators soon (most chapters will have already received it by the time this article is published)

## What the Jury Doesn't Get to Hear

The rules of evidence have a big impact on what the jury gets to hear (and what it doesn't get to hear about the case). A lot of the rules are counterintuitive.

Here's what the jury doesn't get to hear in a motorcycle injury case:

1. The amount defendant offered to pay before trial. In most cases defendants make offers before trial. But at trial the jury never hears what the defendant was willing to pay and the last offer does not set a floor for the verdict.
2. The defendant has insurance. At trial defense lawyers love to insinuate their clients are going to have to pay the full amount of the verdict. Nothing could be further from the truth. But the jury never gets to hear that the insurance company will be paying the verdict.
3. When the defendant admitted fault. A lot of times defendants deny they were at fault from the day of the wreck all the way up to the night before trial. Then, almost magically, they admit fault on the courthouse steps. The jury never gets to hear that the earnest, accountable defendant denied that they caused the wreck for years.
4. The defendant caused 10 other wrecks. A lot of clients want the jury to hear that the defendant caused 10 other wrecks and is a menace to society. The rules of evidence don't allow the jury to hear about these kinds of "past bad acts."
5. The defendant was drunk or high. This is probably the most controversial. Many judges take the view that if the defendant admits he was at-fault for the wreck, the jury doesn't get to find out that he was drunk or stoned.
6. The defendant was texting. If liability is admitted, the jury never finds out that the defendant was texting.
7. The defendant was cited (or the injured person was not cited). Evidence about whether a citation was issued (or not issued) doesn't come into evidence—the jury never hears about it.
8. The defendant never checked on the injured person or asked what they could do to help. What's the best way to truly accept responsibility for hurting someone else? To try to make things right. But the jury isn't going to hear the defendant never checked on the injured person, never offered to drive them to the doctor, and never offered to pay for their medical bills.
9. What similar cases are worth. The jurors are appraisers. Their job is to figure out what the injured person's damages are worth. But the jury is never going to hear that in a very similar case the jury awarded \$1.45M. It's a little like an appraiser potentially saying a house is worth \$100,000 when the ones on either side sold for \$1.55M and \$1.4M.
10. Argument that the jury should put themselves in the shoes of the injured person. How do we typically "understand" things that happen to other people? How do we "empathize" with other people? We put ourselves in the other person's shoes. Unfortunately, the judge won't allow attorneys to encourage the jury to use this commonsense way of understanding what happened to the injured person.
11. Where the money goes after the verdict is paid. The jury isn't told the injured person has to pay back their insurance companies. Or that the injured person has to pay their attorney's fees and costs. The jury is never told that in the U.S. we don't have a "loser-pays" system and that even though defendant forced the injured person to go to trial, the defendant doesn't have to absorb the injured person's fees and costs.

These rules may not seem fair. But it's important to know about them.

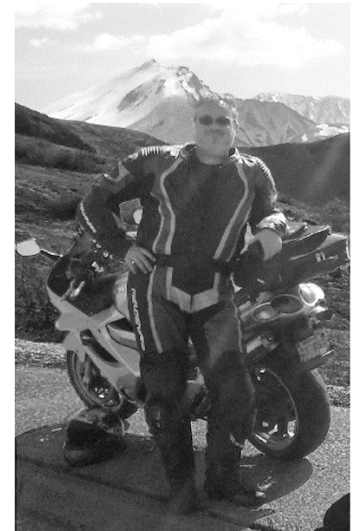
