



### **Ambassador-At-Large REPORTS**


#### **Ron Scott**



#### March 2018 Legislative Report

This year's Black Thursday was a success. With the rain holding off, for the most part, it was sunny at the Capitol as the bikes all rolled in. The speakers on the steps this year kept things fairly short, and informative for the most part. The motorcycle community stood together on the steps of the Capitol; Patch holders, independents, cruiser riders, sport bike riders, and even a few dual-sport riders were in attendance. There were 119 people who signed in within the Columbia Room, and many of those volunteered to be "runners". For the second year in a row, every legislator's

those volunteered to be "runners". For the second year in a row, every legislator's office was at least contacted on Black Thursday. With approximately a third of them actually having meetings scheduled. It would be great if we could get that number up to half by next year. Even better if we could get at least one member from each district to attend meetings with their legislators.

Although rain was forecast, the sun rose in blue skies after pre-dawn showers. The mass ride-in arrived right on schedule after coming down the freeway from the Hawks Prairie Casino to the Capitol campus. It took several minutes for all the bikes just to be able to roll along the south diagonal before parking and filling three-quarters of the north diagonal with motorcycles. Once the crowd gathered on the Capitol steps, several carrying protest signs and banners, it was reminiscent of an old style protest rally. Within the large group of motorcyclists present were a mix of cruiser, touring and even a contingent of sports bike riders.

Instead of paying to "rent" the podium and its wimpy sound system ABATE purchased two megaphones and we used those on the steps for all the speakers. It seemed to help. Allowing speakers to move around a little and still have their words amplified for all to hear. The speakers consisted of; myself and Scott Robinson, David Devereux of the Council of Clubs, Larry Walker of the Washington Road Riders Association, and Washington State Senators Sharon Brown, Dean Takko, Tim Sheldon, and Phil Fortunato. The legislators speaking to the crowd on the steps included members of both parties, and all were sponsors of bills that supported the motorcyclist's rights to ride freely. The enthusiasm that all the speakers were met with definitely showed a mutual respect that comes from working together over a long time.

Our efforts were noted in Quick Throttle Magazine and several online websites. Even the AMA was interested in what ABATE and the motorcycling community of Washington state had done, and what bills we were fighting for, and is including that information in an article in their monthly magazine.

#### OUR BILLS

As I type this, only the Senate version of the Motorcycle Parking Bill (SB6070) is still alive and moving. The companion bill was amended and passed out of the House Transportation Committee and sent to Rules. However, after consideration several key members of the Committee stated they made a mistake after hearing the concerns of several legislators who are law enforcement. The hearing is currently just a few hours away as I write this, and the word is that because the legislators who are or were cops all support our bill the way it is, the bill is expected to be passed out of the Committee without amendments.

We will keep working this bill all the way to the Governor's desk. I would like to hear from ABATE members on issues that they would like us to pursue in the Legislature. The more we can keep these "simple" bills moving the more effective and credible ABATE remains in the eyes of those sitting in the chambers of the Legislature. Our vehicular assault bill is going to be worked on with the assistance of an attorney in Vancouver, WA in order to get the language to a point that the Legislators aren't afraid of the bill and it's effects any longer. Senator Tim Sheldon of the 35th District has said he will introduce the Lane Sharing Bill that passed the Senate last year again in the next biennium. So we will be working on

getting both of those bills passed as well.

I want to thank ABATE's NCOM Ambassador, Sam Bonomo for his hard work and dedication in bringing to light what other Motorcycle Rights Organizations are doing across the country. It is possible that ABATE may take a look at some of those efforts and issues, and bring ones that might work in Washington to the BOD in April. It will take all of us in the community to bring effective motorcycle legislation to Olympia and get it passed in the Legislature. If we can demonstrate it is effective in other states, we may actually get more interest in getting bills moved along.

Keep the Faith and I'll catch you on the road sometime.




